Athletic & Co-Curricular Activities Handbook

Academic, Attendance, and Behavior Requirements

(includes all athletics, student council, clubs, and outside band or choir activities)

2024-2025 School Year

9th-12th Grade Participation Requirements:

- All athletes must have a physical on file (annually for football players) before they PRACTICE. **This is an OSAA Rule**
- All students must have proof of insurance coverage before they can PRACTICE.
- All students must be present the entire day of a contest or the previous day for Saturday contests (unless it is an excused absence, pre-approved by the administration and athletic director)
- Any student who is participating in athletics or co-curricular activities is required to ride the bus to all contests or activities unless previously requested (at least one day prior)
- All students must ride the bus home from contests or activities UNLESS the student is riding with their parent/guardian OR they have a note ON-FILE at the office and a copy provided to the coach or advisor before the contest day.

DUAL PARTICIPATION:

Students are discouraged from participating in more than one sport during a season. If a student and parent/guardians insist on dual participation, then the following applies:

- The team sport should be given practice and contest priority.
- Coaches can decide whether to support dual participation; the athletic department will fully support their decision.
- Coaches are not responsible for coordinating practices for dual sport athletes.
- Students must pay the total fees for both sports.
- There is no guarantee of playing time or participation in either sport; each program should have practice attendance requirements.
- Students and parents/guardians must also sign the dual sport agreement.

9-12th Grade Academic Eligibility

Students participating in co-curricular or athletic activities sanctioned by Central Curry School District 1 must adhere to the following academic requirements. Academic achievement is more important than athletics or other activities. The following guidelines ensure each student is held accountable for their academic achievement during the season and participation timeframe.

At the beginning of each athletic season, all participants' grades from the previous grading period will be reviewed. Academic eligibility will be evaluated throughout the season using interim reports, report cards, and specific information from teachers. For fall activities, 8th graders (incoming 9th graders) will be evaluated according to the fourth quarter of the previous academic year. If an incoming 9th grader is deemed ineligible based on the last academic year, they will begin the season on academic probation.

Academic Eligibility Requirements:

No D's or F's and a GPA of 2.00 or greater.

OSAA Requires the Following Credits each year for eligibility:

Credits to graduate	24
Credits earned per year	6.0
Required prior to 10 th grade	4.5
Required prior to 11 th grade	10.0
Required prior to 12 th grade	17.0

****This does not apply to incoming freshman**

If students fail to meet these minimum requirements at the beginning of the school year, they will be ineligible to participate until they have completed the credit(s).

Grade Checks

Grade checks will be done weekly beginning September 23rd, 2024. A calendar of grade check dates will be provided to the coaches and students before the start of school. Then, they will continue every Monday (Tuesday if there is no school on a Monday). A report from the office registrar will generate these and send them to the principal and athletic director. Pass or No Pass classes only affect a student's GPA if they receive an NP; letter grades must be given (when applicable) to aid in calculating a student's GPA.

Academic Probation:

Any student with Ds or Fs and/or a GPA of 2.00 or lower will be placed on academic probation immediately following the grade checks. Students will have one week to work on

their academic eligibility requirements. During this time, students are eligible to practice and participate in contests.

Academic Suspension:

Academic suspension will occur if students fail to get their grades and/or GPA to meet the requirements. Once a student is on academic suspension, they will have one week to make satisfactory progress toward meeting eligibility requirements. Otherwise, they will remain on academic suspension and be unable to compete until they meet the requirements. During this time, students can practice but not compete in contests. Students on probation or suspension should be strongly encouraged to meet with teachers and make a plan to meet requirements.

HOME SCHOOL STUDENT-ATHLETES ACADEMIC REQUIREMENTS:

OSAA requires that any home-school student who transfers to a public or private school must establish initial academic eligibility by achieving a minimum score on any adopted achievement test (see ODE website for testing options). The student shall achieve a minimum composite test score that places the student at or above the 23rd percentile based on national norms. The achievement test must be completed before August 15 each school year. Testing must be done for all incoming 10th-12th grade home-school students (9th graders will be eligible without prior testing). Testing can be coordinated through the South Coast Education Service District. Central Curry School District 1 cannot offer testing for home school athletes; all testing will be the responsibility of the student and their families. If a student fails to complete the test or does not receive a passing score, they will be ineligible to compete in any OSAA athletic contests.

A checklist can be found on the OSAA website or is available from the High School Office.

High School Requirements:

- Proof of registration in a home school program
- Proof that student is enrolled in 5 or more different classes (OSAA Requirement)
- Copy of annual testing from South Coast Education Service District (SCESD)
- Weekly grade checks (must use letter grades) submitted to the registrar.

9th-12th Grade Attendance Requirements

- Any unexcused absence renders the student/athlete ineligible to compete or practice in activities for that day. (Unexcused absences are outlined in the student body handbook).
- Five to nine unexcused absences within a grading period (every four weeks) will result in the student being ineligible to participate or practice for one week after the grading period.

- ten plus unexcused absences within a grading period (every four weeks) will result in being removed from the activity or athletic team.
- Tardies- if a student has more than two tardies in 1 day, the student is not eligible to participate in practice or contests.
- 3-5 weekly tardies will result in a 1-week suspension from the activity or athletics.
- five or more tardies in one week will result in termination from participation.

9th-12th Grade Behavior Expectations

All students participating in athletics or co-curricular activities represent the Central Curry School District 1 at other facilities and public places. All students should hold themselves to a higher standard when representing our district. All district handbook rules apply during off-campus school-related activities, and violations of the policies will follow the same discipline procedures as outlined in the handbook. When representing Gold Beach Junior Senior High School, students should be model citizens and role models.

- Any student who receives three trackers or one major referral cannot participate in the contest(s) for the next seven days. Students can practice.
- If you are suspended from school (in-school or out-of-school), you are not eligible to attend practice or compete until the duration of the suspension has been served.
- Any violation of the district's alcohol, tobacco, nicotine, or drug policies will immediately terminate participation for the remainder of the season.
- The administration will evaluate any form of criminal behavior other than drug/alcohol offenses to determine disciplinary action for participation in athletics or co-curricular activities.
- Students should ensure that their social media posts are appropriate and do not show students participating in illegal activities. If exposed, the district will report to law enforcement for an investigation and students will be temporarily suspended from participation in the inquiry.
- Any athlete ejected from a contest cannot participate in the following contest (additional action may be taken depending on severity). Administration, coaches, and the athletic director will review each incident.
- Any student who exhibits behavior outlined in the District's handbook, including bullying, harassment, sexual harassment, and physical or verbal assault (fighting), will immediately be removed from the activity or sport.
- District administration, the athletic director, and coaches have discretion in implementing consequences for behavior beyond what is outlined in this handbook.

7th- 8th (and 6th if allowed for sport) Grade Participation Requirements:

- All athletes must have a physical on file (annually for football players) before they PRACTICE
- All students must have proof of insurance coverage before they can PRACTICE
- All students must be present the entire day of a contest or the previous day for Saturday contests (unless it is an excused absence, pre-approved by the administration and athletic director)
- Any student who is participating in athletics or co-curricular activities is required to ride the bus to all contests or activities unless previously approved by administration at least one day prior.
- All students are required to ride the bus home from contests or activities UNLESS the student is riding with their parent/guardian OR they have a note ON-FILE at the office and a copy provided to the coach

DUAL PARTICIPATION:

Students are discouraged from participating in more than one sport during a season. If a student and parent/guardians insist on dual participation, then the following applies:

- The team sport and team in direct competition should be given practice and contest priority.
- Coaches can decide whether to support dual participation; the athletic department will fully support the coach's decision.
- Coaches are not responsible for coordinating practices for dual sport athletes.
- Students must pay the total fees for both sports.
- There is no guarantee of playing time or participation in either sport; each program should have practice attendance requirements.
- Students and parents/guardians must also sign the dual sport agreement.

Middle School- Academic Eligibility Requirement

Students participating in co-curricular or athletic activities sanctioned by Central Curry School District 1 must adhere to the following academic requirements. Academic achievement is more important than athletics or other activities. The following guidelines ensure each student is held accountable for their academic achievement during the season and/or participation timeframe.

At the beginning of each athletic season, all participants' grades from the previous grading period will be reviewed. Academic eligibility will be evaluated throughout the season using interim reports, report cards, and specific information from teachers. For fall activities, grades from the previous grading period will determine eligibility. If a student ends the year with D's, F's, or a lower than 2.00 GPA, they will begin the year on academic probation. They will be off probation if they have met the requirements outlined at the first grade check. They will be on academic suspension if they have not met the eligibility requirements at the first grade check.

Academic Eligibility Requirements:

No D's or F's and a GPA of 2.00 or greater FOR ALL STUDENT-ATHLETES OR CO-CURRICULAR PARTICIPATION

Grade Checks:

Grade checks will be done weekly beginning September 23rd, 2024. A calendar of grade check dates will be provided to the coaches and students before the start of school. Then, they will continue every Monday (Tuesday if there is no school on a Monday). A report from the office registrar will generate these and send them to the principal and athletic director. Pass or No Pass classes only affect a student's GPA if they receive an NP, and letter grades must be given (when applicable) to aid in calculating a student's GPA. Students can no longer go around during the week to verify their eligibility; this will be done solely based on the reports generated by Power School and the student registrar.

Academic Probation:

Any student with Ds or Fs and/or a GPA of 2.00 or lower will be placed on academic probation immediately following the grade checks. Students will have one week to work on their academic eligibility requirements. During this time, students are eligible to practice and participate in contests.

Academic Suspension:

Academic suspension will occur if students fail to get their grades and GPA to meet the requirements. Once a student is on academic suspension, they will have one week to make

satisfactory progress toward meeting eligibility requirements. Otherwise, they will remain on academic suspension and be unable to compete until they meet the requirements. During this time, students can practice but not compete in contests. Students on probation or suspension should be strongly encouraged to meet with teachers and make a plan to meet requirements. The use of recovery time is strongly encouraged.

HOME SCHOOL STUDENT-ATHLETES ACADEMIC REQUIREMENTS:

Home school athletes must submit weekly grade reports to the school office, preferably by email to acarter@ccsd.k12.or.us, no later than 3 pm the business day before the grade check reports are generated. These grade checks must include letter grades and/or a calculated GPA. If a grade check is not submitted for the week by the provided time frame, the student will be considered on academic probation; if it happens again for a consecutive week, the student will be placed on academic suspension and unable to participate in contests.

Middle School Requirements:

- Proof of registration in a home school program
- Weekly grade checks (must use letter grades) submitted to the registrar on the dates requested (dates on the back page).

Middle School Behavior Expectations

All students participating in athletics or co-curricular activities represent the Central Curry School District 1 at other facilities and public places. All students should hold themselves to a higher standard when representing our district. All district handbook rules apply during off-campus school-related activities, and violations of the policies will follow the same discipline procedures as outlined in the handbook. When representing Gold Beach Junior Senior High School, students should be model citizens and role models.

- Any student who receives three trackers or one major referral cannot participate in the contest(s) for the next seven days. Students can practice.
- If you are suspended from school (in-school or out-of-school), you are not eligible to attend practice or compete until the duration of the suspension has been served.

- District administration, the athletic director, and coaches have discretion in implementing consequences for behavior beyond what is outlined in this handbook.

Middle School Attendance Expectations

- Any unexcused absence renders the student/athlete ineligible to compete or practice in activities for that day.
- Five to nine unexcused absences within a grading period (every four weeks) will result in the student being ineligible to participate or practice for one week after the grading period.
- Ten plus unexcused absences within a grading period (every four weeks) will result in being removed from the activity or athletic team.
- Tardies- if a student has more than two tardies in 1 day, the student is not eligible to participate in practice or contests.
- 3-5 weekly tardies will result in a 1-week suspension from the activity or athletics.
- five or more tardies in one week will result in termination from participation.
